#### **Highlights of the 2002 Primary Election**

- Total contributions to legislative candidates have increased 24% since the 2000 Primary Election, out pacing the rate of inflation by nearly six times.
- Legislative candidates raised over \$3.7 million dollars during the primary election. 76% of all contributions went to candidates who won the election. 55% went to incumbents, 34% went to challengers and 11% went to candidates for open seats in the legislature.
- Contributions to candidates from themselves and family members continue to be the biggest source of funding for campaigns, accounting for 22% of all identified contributions to legislative candidates.
- Contributions from health care providers have increased 159% since the 2000 primary election. Other special interest groups on both side of the battle over so-called "tort reform," have also seen significant increases since the previous election.
- Many of the top fundraisers were opponents during the primary election, or are facing off in the up-coming general election. For example, four of the 10 house candidates who raised the most money are running in the 27<sup>th</sup> district.
- For the first time since WV-PERC has been tracking campaign contributions to candidates, House Speaker Bob Kiss is not the top fundraiser.

PERC-WV's primary mission is to focus attention on how special interest money influences our democratic institutions in West Virginia. By maintaining a database of special interest contributions to political campaigns, tracking significant bills in the legislature, and issuing reports on our research, PERC-WV educates the public on the significant influence that special-interest money plays in West Virginia politics. PERC-WV underscores problems and proposes solutions based on its research.

People across the political spectrum agree that **special interest money dominates West Virginia politics**, **affecting everyone's issues**. By focusing attention on the source of this campaign cash, PERC-WV encourages changes that can help shift the balance of power from the special interests to the public interest.

In previous reports, PERC-WV has identified blocks of special interest groups that unite to advocate for, or oppose, specific legislation. One of these groups is advocates for so-called "tort reform." A perennial legislative issue is some form of tort reform, and the upcoming legislative session will be no exception. Advocates for tort reform include virtually every all members of the **business community**, **heath care providers**, **the insurance industry and corporate lawyers** who are seeking to put a limit on liabilities of manufacturers and the medical profession. Another special interest block is the "progressive coalition." **Organized labor**, **education organizations**, **trial (consumer) lawyers**, **environmentalists and social justice advocates** often align themselves on issues, including opposing tort reform.
